CONTEST RULES & PHOTO RELEASE AGREEMENT

WHO MAY ENTER

Amateur and professional photographers, except contest judges and employees of Friends of the Mountains-to-Sea Trail and Great Outdoor Provision Co. and their immediate families (children, siblings and spouses).

CATEGORIES

Photos will be judged in two categories:

- 1. View from the Trail
- 2. People on the Trail

DEADLINE

The deadline for submitting photos is 11:59pm on Monday, October 31, 2016. All entries must be uploaded by that time.

WHAT TO ENTER

- A photographer may enter up to two images per category. (See categories above.)
- An image may be entered in only one category.
- Any entrants 17 years or under on October 31, 2016 must have parental consent.
- Entrants must hold all rights to photographs they submit.
- All photographs must:
 - 1. have been taken on the Mountains-to-Sea Trail.
 - 2. be submitted electronically. To submit your photographs go to www.ncmst.org/get-involved/photo-contest/ and follow the instructions.
 - 3. be unaltered beyond standard optimization (cropping, adjustment to color and contrast, etc.)
 - 4. not exceed 2MB
 - 5. be in jpeg format.
 - 6. have image resolution of 10 inches on the long side at 200 dpi.
 - 7. not contain added text or data that appear on the image visually. Metadata embedded into the photograph's file is allowed as long as it does not appear on the image.

PRIZES

- First Place, all categories: \$150 cash prize
